The 8<sup>th</sup> Annual Tour d'Oconee Bike Ride, sponsored by the Oconee County Cycling Organization (OCCO) and Athens Radiology Associates, will take place on **Saturday, May 11, 2019**. The ride is a major fund-raiser for OCCO, Inc., a 501(c)3 non-profit organization. Your participation in Tour d'Oconee will help promote bike safety, improve and expand multi-use bike paths, and facilitate the growth of all types of cycling in Oconee County and beyond.

Tour d'Oconee details:

- **Time** – Begins at 8:00 a.m. Check-in will be in the parking lot behind the Oconee County Courthouse located at 23 N. Main St., Watkinsville, GA 30677.
- **Registration** - Register at [www.oconeecycling.org](http://www.oconeecycling.org) or at the big tent on the day of the event.
- **Cost** – \$35 by May 6<sup>th</sup>, \$45 after May 6<sup>th</sup>. A free lunch will be provided after the ride.
- **Distance** – 62 miles with an elevation of 2,850 ft. of climbs. Optional routes of 32 miles and 24 miles.
- **Rider Support** – Marked and signed routes, vehicle support, and fully stocked rest stops.
- **Children** – Kids are free! Youth and children under 17 years of age as of May 12<sup>th</sup> ride free as long as they are accompanied by at least 1 paying adult. The minimum age is 7.
